This community meeting will now be held on **Wednesday, September 23, 2015 at 6 p.m.** at the **Arrowhead Country Club, 19888 N. 73rd Ave.**

Glendale Fire Saves The Life Of A Child

I would like to take the time to share with you a lifesaving story of a two year old girl and the Glendale Fire Station E153. Young Adelynn was playing on a toddler trampoline when she was found lying face down on the concrete just beside the trampoline. When Adelynn was found unresponsive, 911 was called and Glendale Fire E153 arrived at the home within a couple of minutes. The paramedics worked quickly to secure Adelynn in the ambulance.

Since there were no signs of injury other than Adelynn being unresponsive Glendale Fire knew this was severe. While being transported in the ambulance they administered an intraosseous infusion(IO) which is the process of injecting directly into the marrow of a bone provide fluids and medication.

After arriving at the hospital, doctors immediately began working to save the life of Adelynn. After several hours of surgery, the doctors told the family that if it wasn't for Glendale Fire placing the IO in her leg she wouldn't be alive today. The family was also told that Adelynn's brain never lost oxygen while being transported to the hospital.

The life-saving techniques performed by Glendale Fire not only saved Adelynn's life, they saved the lives of her family and community who would have dealt with the pain of losing a loved one. Adelynn has since made a full recovery and the family now shares a special
