THE LINKING AGREEMENT  
WITH  
WESCO DISTRIBUTION INC. DBA BROWN WHOLESALE ELECTRIC  
(State of Arizona Contract No. ADSPO14-064773, Contract No. C-10459)

This Amendment No. 1 ("Amendment") to the Linking Agreement ("Agreement") is made this 28 day of April, 2016, ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Wesco Distribution Inc. dba Brown Wholesale Electric, a Delaware corporation authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Wesco Distribution Inc. dba Brown Wholesale Electric ("Contractor") previously entered into Linking Agreement, Contract No. C-10459, dated November 24, 2015 ("Agreement"); and
- B. The original State of Arizona Contract, Contract No. ADSPO14-064773 had an initial term beginning February 1, 2014 through January 31, 2015 with the option to extend an additional four years (4) years in one-year increments; and
- C. The State of Arizona Contract, Contract No. ADSPO14-064773, as amended expires on January 31, 2017; and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.


AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of the Agreement is extended for a one-year period from February 1, 2016 through January 31, 2017, unless otherwise terminated or canceled as provided by the Agreement. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
3. **Scope of Work.** The scope of work is unchanged
4. **Compensation.** The compensation is unchanged

5. **Insurance Certificate.** Current certificate will expire on June 4, 2016 and a new certificate applying to the extended term must be provided prior to this date to Materials Management and the Contract Administrator.
  
6. **Non-discrimination.** Contractor must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic characteristics, familial status, U.S. military veteran status or any disability. Contractor will require any Sub-contractor to be bound to the same requirements as stated within this section. Contractor, and on behalf of any subcontractors, warrants compliance with this section.
  
7. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




