AMENDMENT NO. 4 SECURITY GUARD SERVICES AGREEMENT (Solicitation No. RFP 12-03 Contract No. C-7816)

This Amendment No. 4 to Security Guard Services Agreement ("Amendment") is made to be effective the 22nd day of November, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Confidential Background Investigations Inc., a Utah corporation authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Contractor previously entered into Security Guard Services Agreement, Contract No. C-7816, dated November 22, 2011 ("Agreement"); and
- B. The Agreement had an initial one-year term beginning November 22, 2011 through November 21, 2012, and provided the option to extend the term for an additional four (4) years in one-year increments; and
- C. City and Contractor previously entered into Amendment No. 1, extending the term of the Agreement from November 22, 2012 through November 21, 2013; and
- D. City and Contractor previously amended the Agreement, extending the term of the Agreement from November 22, 2013 through November 21, 2014.
- E. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT


In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of the Agreement is extended for a one-year period from November 22, 2014 through November 21, 2015, unless terminated, canceled or extended as provided within the Agreement. All other provisions of the Agreement shall remain in their entirety.
3. **Scope of Work.** The Scope of Work is changed as follows:

The following security guard service has been discontinued on Contract C-7816 Exhibit A page 2 City of Glendale Patrol #1 effective June 30, 2014. No patrol vehicles for the Glendale Memorial Park Cemetery, Sahuaro Ranch Historical Area, and Manistee Ranch. In addition, Community Action Program guard services have been discontinued. All other services shall remain the same.


4. **Compensation.** Contractor's compensation is amended as of the Effective Date of this Amendment and Exhibit B of the original Agreement is amended as set forth in Exhibit B-Amendment No. 4, attached hereto.
5. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.





EXHIBIT B-AMENDMENT NO. 4

**SECURITY GUARD SERVICES AGREEMENT
AMENDED COMPENSATION**

METHOD AND AMOUNT OF COMPENSATION

Compensation for services performed will be paid per weekly itemized invoices issued by the Contractor and approved for payment by the Contract Administrator at the rate of:

- **\$13.18** per hour for regularly scheduled shifts
- **\$13.99** per hour for additional sites
- **\$18.51** per hour for additional special event and emergency services, if requested by City.

NOT TO EXCEED AMOUNT

The total amount of compensation paid to Contractor for full completion of all work required by the Project must not exceed \$571,000.00 for the one-year period of the renewal term.

DETAILED PROJECT COMPENSATION

Contractor shall submit invoices per the PAYMENT Section of Exhibit A and submit activity reports as requested per the DOCUMENTATION AND REPORTING Section of Exhibit A.
