AMENDMENT TO  
AGREEMENT FOR SERVICES

This Amendment (the "Amendment") to the Agreement for Services dated October 22, 2013 and labeled Contract C-8672 by the City of Glendale (the "Agreement") is made this 28<sup>th</sup> day of June, 2016, ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation (the "City"); Global Spectrum, L.P., a Delaware limited partnership ("Global Spectrum"), as agent for the Arizona Sports and Tourism Authority ("AZSTA"); and, SMG, a Pennsylvania general partnership ("SMG").

RECITALS

- A. The City and Global Spectrum, as agent for AZSTA, previously entered into the Agreement; and
- B. Effective July 1, 2016, SMG will become the venue manager for University of Phoenix Stadium (the "Stadium"), and will act as the agent for AZSTA and will have the authority to enter into service agreements on behalf of AZSTA, the entity that owns the Stadium; and
- C. The City desires to acknowledge SMG as the agent for AZSTA effective as of July 1, 2016 in connection with the Agreement; and
- D. Prior to July 1, 2016, the City and Global Spectrum, on behalf of AZSTA, wish to amend the Agreement by extending its term in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth in this Amendment and other good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the City, Global Spectrum and SMG agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Acknowledged and Acceptance of New Agent.** The City hereby acknowledges SMG as the manager of the Stadium and as AZSTA's agent in connection with the Agreement, effective as of July 1, 2016.
- 3. **Term.** The term of the Agreement is extended so that the Agreement now expires September 30, 2016, unless otherwise terminated or canceled as provided by the Agreement. This paragraph modifies and supersedes the conflicting provisions of Paragraph 4 of the Agreement, but all other provisions of the Agreement except as set forth in this Amendment remain in their entirety.


4. **Non-discrimination.** SMG must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic characteristics, familial status, U.S. military veteran status or any disability. SMG will require any Sub-contractor to be bound to the same requirements as stated within this section. SMG, and on behalf of any subcontractors, warrants compliance with this section.
  
5. **Ratification of Agreement.** The City, SMG and Global Spectrum agree that except as expressly provided in this Amendment, the provisions of the Agreement remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment prevail.




