**AMENDMENT NO. 1
TO
LINKING AGREEMENT BETWEEN
THE CITY OF GLENDALE, ARIZONA
AND
QCM TECHNOLOGIES
(
Glendale Contract No.C-9545)**

This Amendment No.1 (the "Amendment") to the Linking Agreement (the "Agreement") is made this 21 day of April, 2016 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City) and (QCM Technologies), an Arizona corporation authorized to do business in Arizona ("Contractor").

RECITALS

- A. The City and QCM Technologies, ("Contractor") previously entered into a Linking Agreement, Contract No. C-9545, dated December 18, 2014 in which Contractor agreed to provide goods and/or services to the City in accordance with those goods and services described in the Mohave Educational Services Cooperative Contract Number 13U-QCM-0129; and
- B. The Mohave Educational Services Cooperative Contract Number 13U-QCM-0129 had an initial term beginning January 29, 2014, and continuing through January 28, 2015 with the option to extend an additional four (4) years in one-year increments;
- C. The Mohave Educational Services Cooperative Contract Number 13U-QCM-0129, as amended, expires on January 29, 2017; and
- D. City and Contractor therefore wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AMENDMENT

In consideration of the mutual promises set forth in this Amendment and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the City and Contractor agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.

2. **Term.** The term of this Agreement is extended for a one-year period from January 29, 2016 to January 29, 2017 unless terminated or canceled as provided by the Agreement.

3. **Non-discrimination.** Contractor must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic characteristics, familial status, U.S. military veteran status or any disability. Contractor warrants compliance with this section.

4. **Ratification of Agreement.** All other provisions of the Agreement remain in effect in their entirety. If any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment prevail and control.






