

RESOLUTION NO. 3380 NEW SERIES

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 16, 2000; AND ORDERING THAT A CERTIFIED COPY OF THIS RESOLUTION BE RECORDED.

WHEREAS, the City Council of the City of Glendale, Maricopa County, Arizona, by Resolution No. 3361, New Series, adopted on the 28th day of March, 2000, did cause a notice to be submitted to the qualified electors of the City of Glendale (the "City") of a General Election called and held in and for the City on the 16th day of May, 2000 for the runoff election of candidates for the office of Councilmember in the Yucca District and a proposition to seek approval of a permanent adjustment to the 1979-80 Base Expenditure Limitation of the City of Glendale; and

WHEREAS, the City Council did cause notice of the General Election to be given by the City Clerk publishing notice thereof in The Glendale Star newspaper as provided by law, such newspaper published in and having general circulation within said City. Said notice, as so published, did specify the place where such election was to be held and the candidates and proposition to be voted upon. A copy of said notice, with the affidavit of publication attached thereto, is now on file and a part of the official records of the City Council of Glendale; and

WHEREAS, the election returns have been presented to and have been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. That the total number of ballots cast at said General Election, as shown by the cumulative report of polling places, with the addition of ballots to be verified and early ballots processed, was 6,821.

SECTION 2. That the total number of early ballots cast at said General Election was 4,905. For the reasons listed below, 57 of these early ballots were found to be invalid.


SECTION 6. That the total number of votes cast for Proposition 402 were as follows:

SECTION 8. That the City Clerk be instructed and authorized to forward a certified copy of this resolution for recording to the Maricopa County Recorder's Office.




