

RESOLUTION NO. 3445 NEW SERIES

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, ADOPTING APPLICATION AND LICENSE FEES, PURSUANT TO GLENDALE CITY CODE, CHAPTER 4, FOR LIQUOR LICENSES; AND SETTING FORTH AN EFFECTIVE DATE.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. That pursuant to the Code of the City of Glendale, Chapter 4, Article II, Sec. 4-23, the application and license fees for liquor licenses set forth in Exhibit A attached hereto are hereby established.

SECTION 2. That the provisions of this Resolution shall supersede all provisions contained in Section 2 and Exhibit "B" of Resolution No 3101 New Series.


SECTION 3. That the provisions of this Resolution shall be effective as of April 1, 2001.




