

RESOLUTION NO. 4900 NEW SERIES

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF GLENDALE GENERAL ELECTION HELD NOVEMBER 4, 2014; DECLARING THE ELECTION OF THREE COUNCILMEMBERS; AND ORDERING THAT A CERTIFIED COPY OF THIS RESOLUTION BE RECORDED.

WHEREAS, the City of Glendale held a General Election Tuesday, November 4, 2014, for the purpose of electing persons to the office of Councilmember in the Cholla, Barrel, and Ocotillo Districts; and

WHEREAS, A.R.S. § 16-642 requires that the City council canvass the returns of the election not less than six days nor more than 20 days following the election; and

WHEREAS, the City Council having canvassed the returns of the November 4, 2014 General Election, finds the returns to be as stated in this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. That the total number of ballots rejected was 173 (Exhibit A).

SECTION 2. That the total number of provisional ballots to be verified at said General Election, shown on Maricopa County's Provisional Ballots printout (Exhibit B) was 940. Of these 86 ballots to be verified were found to be invalid.

SECTION 3. That the total number of ballots cast at said General Election, as shown by the Precinct Canvass report was 21,017 (Exhibit C).

SECTION 4. That the votes cast for the candidates for Councilmember were as follows:
