GENERAL OVERVIEW

Executive Summary

The State and Local Fiscal Recovery Funds (SLFRF) program is a significant initiative aimed at providing much-needed financial assistance to state, local, territorial, and Tribal governments in the United States. The program was established as part of the American Rescue Plan Act of 2021, which was enacted in response to the economic challenges caused by the COVID-19 pandemic.

The primary objective of the SLFRF is to help governments, like the City of Glendale, address the adverse economic and fiscal impacts they have experienced due to the pandemic. The program provides substantial funding to support a wide range of eligible uses, offering flexibility and discretion to the recipients to allocate the funds according to their specific needs and priorities.

The program allocates \$350 billion in funding to state, local, territorial, and Tribal governments, with different allocation formulas based on population size and other factors. The funds can be utilized for a variety of purposes, including but not limited to:

- <u>COVID-19 response and mitigation efforts:</u> Governments can allocate funds for public health expenses, vaccination programs, testing and contact tracing, personal protective equipment, and other measures aimed at preventing, detecting, and responding to the ongoing pandemic.
- Addressing negative economic impacts: Funds can be used to support businesses and industries severely affected by the pandemic, provide assistance to unemployed individuals, and implement initiatives to stimulate economic recovery.
- <u>Supporting essential public services:</u> Governments can invest in the maintenance and improvement of critical infrastructure, including water, sewer, and broadband systems. Funding can also be used to bolster educational systems, ensure access to affordable housing, and enhance public safety measures.
- <u>Premium pay for essential workers:</u> Recipients can use funds to provide additional compensation to essential workers who faced heightened risks during the pandemic, such as healthcare professionals, first responders, and other frontline workers.
- Revenue replacement: Governments can utilize the funds to offset declines in revenue due to the pandemic, thereby preventing cuts in essential services and minimizing the need for layoffs or furloughs of public employees.

The City of Glendale developed a strategic plan for the SLFRF to promote a response to the pandemic, address economic recovery, and support our employees. Staff met with the Glendale City Council on September 28, 2021, to discuss and seek guidance on developing the priorities for the use of these funds.

With the funds, the City seeks to improve the lives of those we serve through the equitable use of these funds. Key priorities include strengthening public health by building healthy communities, addressing the negative economic impacts of the pandemic, strengthening public safety, and improving city infrastructure to better respond to future challenges.

To ensure accountability and transparency, recipients of the State and Local Fiscal Recovery Funds are required to report regularly on their use of the funds, including detailed expenditure

and impact information. The U.S. Department of the Treasury oversees the program's implementation, providing guidance and support to assist recipients in effectively utilizing the funds and complying with reporting requirements.

The City is grateful for the recovery funds that have been made available by Congress and intends to make critical investments that will help strengthen our economy and provide benefits to our citizens for many years to come.

Uses of Funds

The City of Glendale is committed to ensuring that SLFRF investments in our communities are efficient and effective in creating a strong and equitable recovery from the COVID-19 pandemic. In determining use of funds, the City of Glendale leveraged U.S. Census data, internal data, the City's comprehensive plan, and Department leaders to best allocate SLFRF monies that will maximize community impact and resiliency. The following table was taken from the U.S. Census website and compares Glendale, Arizona to the State of Arizona and the United States:

Public Health

To respond to the impacts of the pandemic the City is devoting approximately \$2.1 million of SLFRF funds to address public health impacts. This includes funds for vaccination against COVID-19, prevention, and mitigation of transmission of COVID-19, direct medical expenses for the treatment of COVID-19, and capital investments in our public facilities to respond to the COVID-19 pandemic as well as any future public health emergencies.

Negative Economic Impacts

The city believes that the public health of our most vulnerable citizens can be improved through access to neighborhood features that promote health and safety. These features include access to well planned, modern, and safe parks, recreational amenities, and youth and teen programs. As such the city devoted approximately \$33.8 million to improve city parks, community centers, and programing for our citizens. Funds in this category will also be used to speed the recovery of impacted industries.

Supporting Public Sector Employees

The COVID-19 pandemic severely impacted public sector staffing and had a profound impact on public safety (police and fire) employees as well as all employees who regularly have contact with the public. This has presented a severe challenge in recruiting and retention of public sector staff. The city will utilize approximately \$14.7 million to retain and recruit public sector staff as well as increase hiring incentives for public safety employees to help ensure the safety of our citizens.

Infrastructure

The city will repair and upgrade infrastructure to alleviate local drainage problems within certain areas of the city. Additionally, funding will be allocated to increase energy efficiency and conservation at public facilities. The city has allocated approximately \$1.2 million for these improvements.

Revenue Replacement

The City of Glendale obligated its \$6.7 million allocation for Revenue Replacement by the obligation deadline of December 31, 2024. Projects in this expenditure category are detailed in the "Project Inventory" section of this report.

Community Engagement

The City of Glendale actively engages its communities in numerous aspects of city-planning such as regular <u>City Council meetings</u>, the annual budget approval, General Plan, street improvements, water resource planning, and through participation in <u>Boards and Commissions</u>. Additionally, Glendale engages residents by hosting community meetings, disseminating social media messaging, providing on-site engagement and resources at city events, and through website updates.

Labor Practices

The City of Glendale is committed to ensuring that the strongest labor standards are adhered to. For all infrastructure projects the city ensures that staff and contractors comply with Federal and State of Arizona labor standards. Specifically, the City of Glendale adheres to the Contract Work Hours and Safety Standards Act for all federal funded projects as well as Equal Employment Opportunity language in contracts. In executing agreements with contractors, the City of Glendale includes an addendum outlining federal requirements and requirements specific to the American Rescue Plan Act (ARPA) of 2021 such as:

- Minority and Women Business Enterprises: Assuring the Contractor agrees to take affirmative steps to assure that women and minority businesses are utilized when possible as sources of supplies, equipment, construction, and services.
- Suspension and Debarment: Assuring that none of the Contractor's principals or its affiliates are excluded or disqualified.
- Byrd Anti-Lobbying Amendment
- Access to Records
- Prohibition on certain telecommunications and video surveillance services or equipment (Huawei and ZTE)
- Buy USA Domestic preference for certain procurement using federal funds

NOTE: Due to recent federal executive orders, some of the requirements outlined in the American Rescue Plan Act of 2021 may no longer apply. City staff are working with contractors to determine any impact to the scope of respective projects.

Use of Evidence

The City of Glendale developed key performance indicators for programs, projects, and planned activities. The key performance indicators are included in the Project Inventory section, with an accompanying link to the related evidence-based intervention, where applicable.

Performance Report

The City of Glendale's use of SLFRF funds are outlined in this report (section "Project Inventory"). Each project was evaluated for key performance indicators. Most projects (i.e., use of SLFRF funds) replace or rehabilitate aging infrastructure such as parks. The section "Project Inventory" provides detailed information by project including any key performance indicators utilized by project.
