# Glendale's Boards & Commissions

Community participation is a cornerstone to the City of Glendale's success. Residents play an essential role in shaping our City through volunteerism and providing valuable feedback to our elected officials and City leaders.

**Citizen involvement and input is essential to the success of local government. The City encourages you to consider applying for appointment to one of Glendale's boards and commissions.**

The time commitment for service on a board or commission varies, but most meet at least once a month for several hours.

Board and commission members are appointed by the Glendale City Council.

Please look over the following list of boards and commission to find one that interests you.

## Arts Commission

Advises the City Council on the administration and formulation of Glendale's Municipal Arts Plan and the Performing Arts Partnership Program. Recommends and commissions publicly funded art for the City.

**Meets:** 6:00 p.m., 3<sup>rd</sup> Tuesday of each month

## Audit Committee

The Audit Committee acts as an advisory body to the City Council by making recommendations regarding the independent internal audit program.

**Meets:** As needed.

## Aviation Advisory Commission

Advises the City Council on the maintenance and operation of the Glendale Municipal Airport and its role in statewide air transportation.

**Meets:** 6:00 p.m., 3<sup>rd</sup> Wednesday of each month

## Board of Adjustment

Holds public hearings on requests for variances and appeals to City administrative decisions regarding zoning.

**Meets:** 4:00 p.m., 2<sup>nd</sup> Thursday of each month

## Citizens Transportation Oversight Commission

Monitors the transportation fund to ensure voter-approved projects, in accordance with Proposition 402, are completed in a timely and cost-effective manner. Advises the City Council on regional transportation issues, public transit, the bicycle program and alternative transportation modes.

**Meets:** 6:00 p.m., 1<sup>st</sup> Thursday of each month

## Citizens Utility Advisory Commission

Provides the City Council with recommendations regarding policies and strategies related to City infrastructure, including the City's landfill and solid waste services, regional collaboration, water resources sustainability, operations and infrastructure to ensure the well-being and quality of life of Glendale residents and businesses.

**Meets:** 6:00 p.m., 1<sup>st</sup> Wednesday of each month

## Commission on Diverse Cultures

Makes recommendations to the City Council on ways to encourage mutual respect and understanding among all people, to discourage prejudice and discrimination, and to support cultural awareness and unity of the community.

**Meets:** 6:00 p.m., 2<sup>nd</sup> Wednesday of each month

## Community Development Advisory Committee

Makes recommendations to the City Council regarding the allocation of Community Development Block Grant (CDBG) funds to eligible area non-profit groups; advises City Council on policies related to the City's Community Housing programs and the City's Community Action Program (CAP); provides general advice on human services in Glendale as related to the administration of these programs.

**Meets:** 5:30 p.m., 3<sup>rd</sup> Thursday of each month

## Historic Preservation Commission

Advises the Planning Commission and City Council on issues such as the designation of historic properties and assists in building community support for preservation issues.

**Meets:** Jan, May, & Sept 4:00 p.m., 4<sup>th</sup> Thursday

## Industrial Development Authority

Issues revenue bonds to projects eligible for financing under Arizona statutes.

**Meets:** As needed

## Library Advisory Board\*

Advises the City Council on policies related to the administration and provision of library services.

**Meets:** 6:00 p.m., 2<sup>nd</sup> Wednesday of each month

## Municipal Property Corporation

A non-profit corporation that assists the City with the financing and construction of public facilities in accordance with specifications approved by City Council. The Municipal Property Corporation sells bonds to obtain the necessary funds to construct public facilities.

**Meets:** As needed.

## Parks and Recreation Advisory Commission\*

Advises the City Council on policies, rules, and regulations relating to planning, acquisition, disposition, operations, use, care, and maintenance of parks and recreational facilities. Responsible for development of a master plan for the City's parks system and recreation programs.

**Meets:** 5:30 p.m., 2<sup>nd</sup> Monday of each month

## Personnel Board

Advises the City Council and the City Manager on the merit system and personnel policies and administration. The board also hears appeals regarding discipline.

**Meets:** As needed.
