### **Public Housing – Project Based Voucher - Housing Choice Voucher Waiting Lists Open September 9<sup>th</sup> through September 30<sup>th</sup>**

Beginning **Monday, September 9, 2024, at 8:00 a.m., through Monday, September 30, 2024 at 5:00 p.m.**, the Glendale Housing Authority will be accepting applications to establish waiting lists for several housing programs including Public Housing, Housing Choice Voucher, and Project Based Vouchers which includes Centerline on Glendale at 6775 N 67<sup>th</sup> Avenue which is nearing completion (for unhoused and very-low-income applicants) and Glendale Senior Apartments which is under construction (for senior applicants ages 62 and up). Only one application per household will be accepted, however households may submit interest for multiple programs on the same application. Every household that submits an application will be placed into a random drawing for each program that they select, therefore a household could be drawn for multiple waiting lists. All applicants will be notified of their status after the random drawing takes place.

**MORE ABOUT THE THESE PROGRAMS:**

All programs are federally funded and provide low-rent housing to income-eligible households. At least one member of the household must be a U.S. citizen or have a qualifying immigration status to be eligible for the programs, but that does not have to be the person completing the application and the eligible person is not required to be an adult. Households must meet income-eligibility and other screening requirements if selected.

The Public Housing program allows participants to lease rental housing at three city-owned and operated apartment-style properties in Glendale with units ranging from one to four bedrooms.

The Housing Choice Voucher (HCV) program allows participants to lease rental housing located in Glendale's service area with any landlord who is willing to participate in the program. This includes apartment communities as well as rental homes.

The Project Based Voucher (PBV) program is a site-based rental assistance program.

The City of Glendale has identified the following individual/household characteristics for priority placement if selected to be on a waiting list.

- Living, Working, or Last Permanent Residence in Glendale
- Employed, Elderly (62 or older), Disabled, or Military (active duty or veteran)
- Currently Homeless or At Risk of Homelessness
- Domestic Violence Crime Victim (assault, dating violence, sexual assault, stalking, etc.)
- Displaced by Government Action or Disaster

**COMMITMENT TO FAIR HOUSING AND NONDISCRIMINATION**

It is against the law to discriminate against anyone because of race, color, religion, sex, national origin, familial status, or disability. The City of Glendale is committed to taking meaningful action to affirmatively further fair housing initiatives including:
