I. Purpose:

To facilitate commerce during the November/December holiday period, the City imposes an annual moratorium on construction and maintenance activities, along various roadways within the City to reduce impacts on business resulting from construction activities.

II. Moratorium Period:

The moratorium period begin on the Monday prior to the Thanksgiving holiday weekend and extends to the first Monday after the new year.

III. Directive:

No roadway work requiring full or partial lane closures, other than emergency work, will be permitted on any of the roadways covered by the area/roadways described herein:

1) Westgate Entertainment Area:

- a. Glendale Avenue between 83rd Avenue and 99th Avenue
- b. Maryland Avenue between 83rd Avenue and 99th Avenue
- c. Cardinal Way between 91st Avenue and 99th Avenue
- d. Camelback Road between 83rd Avenue and 99th Avenue
- e. 99th Avenue between Northern Avenue and Camelback Road
- f. 95th Avenue between Northern Avenue and Camelback Road
- g. 93rd Avenue between Glendale Avenue and Maryland Avenue
- h. 91st Avenue between Northern Avenue and Camelback Road

- i. Zanjero Boulevard between Glendale Avenue and 91st Avenue
- j. Entertainment Boulevard and Hanna Drive in its entirety
- 2) Arrowhead Town Center:
 - a. 75th Avenue between Union Hills and Bell Road
 - b. Bell Road between 75th Avenue and AZ Loop 101
 - c. 83rd Avenue between City limits south of the Union Hills intersection and Bell Road
 - d. Union Hills between 75th Avenue and the city limits on the west side of the 83rd Avenue Intersection
- 3) Downtown Glendale:
 - a. Glendale Avenue between 51st Avenue and 59th Avenue
 - b. Glen Avenue between Grand Avenue and 51st Avenue
 - c. Myrtle Avenue between Grand Avenue and 51st Avenue
 - d. 59th Avenue between Myrtle Avenue and Glendale Avenue
 - e. 58^{th} Avenue, 58^{th} Drive, 57^{th} Avenue, 57^{th} Drive, 56^{th} Avenue and 56^{th} Drive Between Glendale Avenue and Myrtle Avenue.
- 4) Bell Road between 51st Avenue to AZ Loop 101

IV. Permitted Activities

The following are permitted activities during the moratorium period

- 1) Special events such as parades or sporting events are exempt from the moratorium requirement.
- 2) Landscaping work not requiring any roadway and or sidewalk closures
- 3) Signal system maintenance
- 4) Roadway striping (nighttime work)
- 5) Street Lighting maintenance (nighttime work)

V. Waiver:

A waiver of the mortarium restrictions may be requested and will only be considered for the following scenarios:

1) Emergency Work:

Emergency work is defined as an unforeseen activity that is urgent, unexpected, and addressing a usually dangerous situation that poses an immediate risk to the health, life, property, or environment and requires immediate action to protect the interest of the City and its residents.

In the case of an emergency, the City's Barricading Division Manager has the authority to grant the waiver

2) A short-term construction activity needed to complete a project that was ongoing prior to moratorium period taking effect. A waiver must be requested from the City Traffic Engineer. The waiver, if granted. will require the applicant to perform their construction activities Monday through Friday between the hours of 11:00 PM and 5:00 AM. No day work will be authorized.

VI. Contractors Responsibility:

Contractor will be responsible for notifying the city's Barricading Division if they are unable to complete a project prior to the moratorium restrictions taking place. The contractor shall give a two week notice so that the City can notify business and residents in the area. The City reserves the right to apply penalties during this period for failure to comply with the permit requirements.
