- Annual and 15-Punch Memberships are valid 1-year from the date of purchase.
- The Fitness Center allows those the age of 13 and up. Those ages 13-14 must be accompanied by a parent or guardian with a membership.
- No refunds or transfers of membership once the purchase has been made.

- *A Glendale Resident is defined as a dwelling where utilities are paid to. Please include a current copy of your water bill with identification. This will be used in conjunction with the City of Glendale boundary map.*
- *2 Persons Membership is identified as any two people residing at the same address*
- *A Family Membership is identified as two adults, and any children residing at the same address, 19 years of age or younger.*
- *A Group/Corporate membership is identified as a maximum of 20 people, ages nine and above where 51% are Glendale residents or a company with a business address within the City of Glendale boundaries and pay City of Glendale taxes. One form of payment is allowed for a group/corporate membership and membership transfers are not allowed.*
