**COMMUNITY REVITALIZATION DIVISION PRESENTS  
ANNUAL PERFORMANCE REPORT FOR PUBLIC REVIEW**

**GLENDALE, Ariz.** – Glendale’s Community Revitalization Division’s annual performance and evaluation report for the fiscal year 2006-07 is available for public review through Sept. 24.

Officially called the Consolidated Annual Performance and Evaluation Report (CAPER), this document is a summary of Glendale’s performance in the administration of Community Development Block Grant (CDBG), Emergency Shelter Grants (ESG) and HOME Investment Partnerships (HOME) programs.

During fiscal year 2006-07, Glendale expended approximately \$4,108,458 of CDBG, ESG and HOME funds to provide citizens with affordable housing, viable neighborhoods and quality living environments.
